



Protocol for the Affiliation

of

**(NAME of the GAR/LING) with the International Dzogchen
Community**

The present Protocol is composed of 4 sections:

Section 1 - Recital

In the fall of 2012, in the attempt to improve the organizational structure of the Dzogchen Community, Chögyal Namkhai Norbu has founded a new non-profit association called International Dzogchen Community (hereafter IDC) based in Arcidosso (GR) Italy. This association is the organizational umbrella under which the network of the different bodies of the Dzogchen Community worldwide is formally established within a functional organizational structure.

All the new Gars and Lings of the International Dzogchen Community become part of this network by complying with the requirements of the IDC Statute.

The Gars and Lings of the Dzogchen Community, already legally established before the foundation of the IDC, have been requested by Chögyal Namkhai Norbu to become formally affiliated with the International Dzogchen Community by amending their existing statutes in compliance with the legislation of the country where they are based, accordingly to the requirements indicated in the International Dzogchen Community Statute.

The present protocol formalizes the affiliation of (Name of the Gar/Ling) with the International Dzogchen Community.

Section 2 – Agreement

..Name of the Gar/Ling.... (hereafter referred to as "Association") recognizes itself as an association integrated in the network and organizational structure of the International Dzogchen Community and that the affiliation with the IDC will further its mission and purposes. The General Assembly of the members of the Association has deliberated to apply for the affiliation with IDC and it has entrusted the Gakyil (Board of Directors) to appoint the legal representative of the Association to sign the present Protocol.

Therefore the parties agree as follows:

1. ..Name of the Gar/Ling.... hereby adopts the Statute of the International Dzogchen Community, in the form attached to this Agreement, together with the Association's Statute drafted in compliance with IDC Statute, which is also attached to this agreement. By adopting the Statute, ..Name of the Gar/Ling.... shall conduct its operations, in accordance with the Statute of IDC and its own Statute .
2. ..Name of the Gar/Ling.. hereby adopts the *International Dzogchen Community Membership Regulations* attached to this Protocol.
3. ..Name of the Gar/Ling accepts the terms of the Code of Use for International Dzogchen Community Trademarks, Logos and Brands also attached to this Protocol.
4. Any potential activities of the Gar/Ling that are described in the Statute, that are regulated by law shall be conducted only to the extent permitted by applicable law.
5. ..Name of the Gar/Ling.... will maintain its administrative autonomy and it will continue to be organized and operate for the non profit purposes stated in its Statute.
6. The governing, administrative and executive bodies of ..Name of the Gar/Ling.... are solely responsible for any liability incurred; they are solely answerable for their own funds and for their own governing, administrative and executive bodies.
7. Name of the Gar/Ling.... accepts the principle of the non-transferability onto the IDC of any obligation assumed by the Association's Gakyil. IDC accepts the principle of

non-transferability onto ..Name of the Gar/Ling.... of any obligation assumed by the IDC Gakyil

The undersigned declare to have read and understood the documents listed in the Recital and attached to this Protocol and they accept the terms and requirements stated in them.

Name of the Gar/Ling accepts the terms of the Affiliation Protocol provided by the IDC. The failure to observe the terms of the Protocol automatically implies the loss of the affiliation and of the right of the use of the IDC trademarks and the name conferred to the Gar/Ling by Chögyal Namkhai Norbu.

The undersigned, by accepting the terms of this Protocol, commit the Association to implement this agreement in compliance with the rules stipulated in it and in the other documents listed above. .

This Agreement may be terminated by either of the parties at any time, without cause, with 120 days' written notice to the other party.

The termination of the agreement implies for Name of the Gar/Ling the loss of the right to use the name "International Dzogchen Community of Name of Gar/Ling", conferred to the Gar/Ling by Chögyal Namkhai Norbu, and the loss of the right to use any of the IDC trademarks.

Section 3 - Request for authorization of trademarks, logos and brands use

- The trademarks of the International Dzogchen Community and the International Dzogchen Community's logos are protected by law. The Gakyil of the International Dzogchen Community has been given the authority by Chögyal Namkhai Norbu, who has the copyright of both names and logos, to grant use of the International Dzogchen Community trademarks to the local bodies of the Association and to any third parties, in accordance with the provisions of article 43 of the *International Statute*, and in particular the attached *Code of Use for International Dzogchen Community Trademarks, Logos and Brands*;
- This *Code* states that your Gar/Ling is only authorized to use the name “International Dzogchen Community” together with the official name given to your Gar/Ling by the Chögyal Namkhai Norbu, exclusively to promote initiatives and programs relevant to the mission of the International Dzogchen Community;
- The use of the names “Dzogchen Community”, “International Dzogchen Community” and the font of the International Dzogchen Community logos in written form must be written accordingly to the instructions contained in the manual about the use of the International Dzogchen Community brand provided and updated by the International Gakyil; furthermore the logo and lettering must be positioned in the same way as they are presented in the same manual;
- Should the Gar/Ling wish to use the “International Dzogchen Community” names and logos without adding its official name or using geographic descriptions differing from that in the Gar/Ling name, it must request authorization from the International Gakyil;
- Use of the name for personal or commercial reasons is strictly prohibited. The right to use the “International Dzogchen Community” names and logos is temporary;
- Authorization for this use granted through the present agreement to (NAME OF

THE GAR/LING/) by the International Gakyil may be revoked by the International Gakyil, or its delegated authority, at any time and for any reason.
